Warranty and Service

Hassle free returns

All Noble & Noble speaker systems ordered on www.noble-noble.com have a 30-day money back guarantee. During this time, you can return or exchange your purchase for free, and we will ensure that you get your money back. All returns (including exchanges) can be made within 30 days of receipt. As a condition of eligible returns, all returned speaker systems must be unused and must be packaged in the original packaging. Please include purchase invoice, warranty card, gifts and all other accessories which must be undamaged as well. Warranty period of 2 years

All Noble & Noble speaker systems are precision engineered and the authorized distributors and/or authorized dealers provide a warranty against faulty material and/or workmanship for 2 years.

Warranty coverage and limitations

This warranty is only valid in the country of purchase and only applies to the first purchaser of the Noble & Noble speaker systems from an authorized distributor / dealer. This warranty does not extend to any other person or transferee and terminates if you sell or otherwise transfer the Noble & Noble speaker systems to another party / entity.

This warranty does not cover any of the following:

- 1. Normal or fair wear and tear and/or any wear from environmental deterioration of the Noble & Noble speaker systems and/or its components.
- 2. Mechanical damage or derangement of the Noble & Noble speaker systems in transit that is not attributable to the fault of Noble & Noble and its authorized distributor / dealer.
- 3. Deterioration of any consumable components of the Noble & Noble speaker systems which would become worn or depleted through use (e.g. batteries).
